Personal data collected will be used with the purpose that people who access the digital platforms, create a username and password, or provide an authentication mechanism requested to register in the same, in order to access the various modules that each one contains, which have been designed to integrate useful information that can be accessed from a mobile platform, or a website, as appropriate, for mobility, connectivity, environment, citizen participation, climate, and security in Mexico City; and hich allows users to issue reports and complaints through the Unified Citizen Attention System module or to request services in the areas of security and mobility.

The intended use of the personal data collected through this System will be to preload the data of the people who register on the platforms to provide attention and follow-up to their requests.

The Digital Agency for Public Innovation of Mexico City may only make transfers to the following obligated subjects derived from the exercise of its attributions:

(a) Centralized Public Administration of Mexico City:

- 1. Secretariat of the Comptroller General
- 2. Secretariat of Health

b) Decentralized Bodies dependent on the Office of the Head of the Government:

Centro de Comando, Control, Cómputo, Comunicaciones y Contacto Ciudadano de la Ciudad de México (C5) (Command, Control, Computing, Communications and Citizen Contact Center of Mexico City).

c) Deconcentrated Organs of the Ministry of Health of Mexico City, for the exercise of its functions in public health matters:

- 1. Mexico City Health Protection Agency (Agencia de Protección Sanitaria de la Ciudad de México).
- 2. Public Health Services of Mexico City.

d) Constitutionally Autonomous Entities

- 1. Human Rights Commission of Mexico City; for the investigation of complaints and denunciations for alleged violations of human rights;
- 2. Institute of Transparency, Access to Public Information, Protection of Personal Data, and Accountability of Mexico City, for the substantiation of appeals for review and revocation, complaints and the procedure to determine the probable

non-compliance with the Law for the Protection of Personal Data in Possession of Obligated Subjects of Mexico City.

e) Jurisdictional and Procurement of Justice Entities, for the exercise of their functions regarding investigation and procurement of justice:

1.Jurisdictional and Administrative Bodies of the federal and local jurisdiction; and 2.The Attorney General's Office of Mexico City.
